


- 1. The quotation in sealed cover should be sent to the office of the District & Sessions Judge, Hojai, Assam by post or delivered by hand.
- 2. Interested Registered firms/Enterprise must submit their quotation in a sealed cover as per the format enclosed as Annexure 'A'.
- 3. The quotation in sealed cover containing the financial bids must reach the designated office **on or before 12 p.m. on 06.05.2025**. Bids received after the due date/ time shall not be entertained.
- 4. The received bids shall be opened in this office at 3: 00 p.m. on 06.05.2025 in the presence of the undersigned. All the bidders shall remain present either in person or through authorized representative on aforementioned date and time in the office of the undersigned.
- 5. Incomplete quotation or bids not accompanied with the requisite supporting documents or quotation submitted without sealed envelope shall be summarily rejected without assigning any reason and without any communication.
- 6. This office shall reserve the right to reject any bid without assigning any reasons if there appears to be reasonable and probable cause for same.
- 7. The rates quoted shall be valid for one year from the date of awarding the supply contract/order of the District & Sessions Judge, Hojai.
- 8. TDS will be deducted at the applicable rate from the contract amount.
- 9. The financial bid must mention the rate to be charged by the firm as per the following terms and conditions:

Terms and Conditions:

The bidder must be a registered firm / Enterprise and must submit the necessary documents as follows.

- i) Proof of Current Bank Account of nationalized Bank in the name of the firm.
- ii) Updated Trade license issued by appropriate authority.
- iii) PAN Card in the name of the firm.
- iv) GST registration certificate

 Any other documents which are required for supplying of tendered items to the Govt. Office or as requested by the undersigned.

The firm / Enterprise shall abide by the following terms and conditions:

- The rates should be submitted with GST and without GST separately. The firm should be GST compliant in all respects.
- The rate quoted for each item will be final and in no hike in price shall be considered in the contract period. Further, rate quoted in the price bid should be on door delivery basis to this establishment and should be inclusive of all the fitting works.
- Preference shall be given to Firms with experience in dealing with supply to Govt. Offices/ Departments.
- 4. The bidder shall have to supply the ordered items immediately on receipt of the supply and fitting order. The item supplied should be as per the prescribed specifications and standard and of the best quality available in the market.
- 5. Payment shall be made after satisfactory execution of the supply and fitting work, subject to availability of sufficient budget under the appropriate Head of Accounts (HOA).
- 6. Sample of the items should be submitted wherever necessary as requested.
- The undersigned reserves the right not to accept or reject any or all quotation in part or full and shall not be bound to accept the lowest bidder if other conditions are not met.
- The supplier firm shall submit the warranty documents with the Proprietor/Manager signature and seal and shall undertake to execute the warranty conditions on behalf of the manufacturer.
- The undersigned reserves the right to place repeat order as per Procurement Rules.The supplier firm shall be bound to execute the order at the same quoted rates.
- 10. In case of violation of terms and conditions of the tender document or the supplied items not being authentic or being of poor quality or not providing satisfactory service the undersigned reserves the right to reject the item and the undersigned shall not be held liable in this regard for any loss incurred by the supplier.
