- 4. The rates approved by the Committee constituted for the selection of bidder shall be valid for the financial year 2025-26. Increase and decrease of Prices, Taxes and other statutory duties will not affect the price during this period. The supplier will be responsible for any increase in Prices, Taxes and Duties.
