1. 3. The candidates are required to appear before the driving test committee on the scheduled date and time. The candidate who fails to appear in the driving test on the given date shall not be put to driving test later on and such candidate shall forfeit his right of consideration later on.
4. The candidates shall have to produce his identity proof i.e. Aadhar Card or any identity proof on the scheduled date and venue.
5. **The Driving Test is of qualifying nature and the candidate(s) who qualify the Driving Test shall be considered for the Written Test.**
6. The call letters have also been sent to concerned candidates through regd. Post.
7. No TA/DA shall be paid for participation in the Driving Test.
