Office Order No. 66 dated 15.03.2024

In the light of letter no. 151/Admn. Misc. dated 04.03.2024 of Hon'ble High Court of Jharkhand, Ranchi, (i) to (v) directions have been given with regard to Accessible Committee.

As per report of office, in compliance to the relevant mandate laid down under heading number XIV of the Standard Operating Procedure, (SOP) for preparing Accessible Court Document 2022 of the e-committee, Hon'ble Supreme Court of India communicated vide letter no. 668/Admn. Misc. dated 28.11.2023 of the Hon'ble High Court of Jharkhand, Ranchi, Accessible Committee of the District Court, Lohardaga has already been constituted vide office order no. 1, dated 02.01.2024 of the undersigned.

In view of direction as mentioned in letter no. 151/Admn. Misc. dated 04.03.2024 of Hon'ble High Court of Jharkhand, Ranchi, as per direction no. (ii), every Civil Court has to nominate one person amongst the staffs of the Civil Court as "Nodal Officer" to look after the problems of the litigants who are differently-abled. The mobile number of the said Nodal Officer would be displayed on the official website of the Civil Court as well as at the gates of the Civil Court.

Hence, in view of above direction, there is requirement of partial modification in Accessible Committee. After partial modification, Accessible Committee of the District Court, Lohardaga is reconstituted comprising with the following members :-

Sir/Madam,


With reference to the subject noted above, I am to inform that the Hon'ble Court has been pleased to direct that:

- (i) the constitution of Accessibility Committee for the Civil Courts of the State be published in the official website of the respective Civil Court.
- (ii) every Civil Court and Sub-Divisional Court to nominate one person amongst the staff of the Civil Court as "Nodal Officer" to look after the problems of the litigants who are differently-abled. The mobile number of the said Nodal Officer be displayed on the official website of the Civil Court as well as at the gates of the Civil Court/Sub-Divisional Court.
- (iii) the Accessibility Committee of the Judgeships shall conduct a meeting on quarterly basis and Minutes of the same be duly sent to the Registrar (Establishment) of this Court for placing the same before this Committee.
- (iv) The Principal District & Sessions Judges/Judicial Commissioner, Ranchi should ensure the availability of adequate number of wheelchairs in their Judgeships and Sub-Division for the differently-abled persons (as per the chart enclosed herewith).

The Principal District & Sessions Judges/Judicial Commissioner, Ranchi to co-ordinate with the Civil Surgeon of the respective district for making the dispensary facility available/operational in the premises of the Civil Courts and their Sub-Division (as per the chart enclosed herewith).
