All the panel advocates of District Legal Services Authority, Nadia are hereby notified that the existing panel of Remand and Retainer lawyers of DLSA, Nadia is going to expire at the end of the month of December, 2022 and, therefore, a fresh panel of Remand and Retainer lawyers will be constituted within the month of December, 2022, from the general panel of lawyers of the District Legal Services Authority, Nadia.

The honorarium of Retainer lawyer is Rs. 8,000/- per month and the honorarium of the Remand Advocate is Rs. 3,000/- per month.

There are Four (04) vacancies in the panel of Remand lawyers as follows:-

- 1) In the court of Ld. CJM, Nadia,
- 2) In the court of Ld. Special Judge NDPS Court, Krishnagar, Nadia.
- 3) In the court of Ld. Special Judge POCSO Court, Krishnagar, Nadia.
- 4) In the court of Ld. Judicial Magistrate Court, Nabadwip, Nadia.

The Remand lawyers has to attend court on all the days including holidays. In their absence they have to ensure that their 'Standby lawyer' must attend the Court. Absence will be strictly dealt with.

There are two (02) vacancies for the full time Retainer Lawyers of the District Legal Services Authority, Nadia (DLSA, Nadia).

The Retainer Lawyers will have to attend the office of the DLSA, Nadia (A.D.R centre building, Nadia) on all the working days from 10.00 A.M to 05.00 P.M. Their honorarium will have deducted in proportionate to their absence on any particular day. The Retainer lawyers may be asked to attend legal awareness camp, to defend an accused in case of absence of Remand lawyer and counseling.


**Therefore, interested panel lawyers are requested to submit their application in prescribed format by 15<sup>th</sup> December, 2022.**

**The Panel Lawyers can make application only against one particular vacancy. If they make multiple applications for different vacancies, all the applications will be liable to be rejected.**

The application along with supporting documents like Educational Certificate, Enrollment Certificate etc. shall be addressed to the Ld. Chairman, District Legal Services Authority, Nadia at Krishnagar.

No application shall be entertained if submitted beyond **15<sup>th</sup> December, 2022.**
