- III. For English Steno-Typist: Minimum Madhyamik or its equivalent, English Short hand Speed 80 w.p.m., English Type Writing -30 w.p.m. Knowledge in English & Bengali language and Computer Operation.
- IV. For Bench Clerk (Peshkar): Minimum Madhyamik or its equivalent. Knowledge in English & Bengali language and Computer Operation.
