eCommittee Conducts the First Ever Digital Accessibility Training for Visually Challenged Judicial Officers & Court Officials



The e-Committee, Supreme Court of India conducted the first ever Digital Accessibility ICT training for Visually challenged Judicial Officers and Court staff on 17 & 18 April 2023 at IIPA, New Delhi. The Hon'ble Chief Justice of India, Dr Justice D.Y. Chandrachud, interacted with the participants from various parts of the country and heard their suggestions and feedback on the training. Making the digital infrastructure of the Indian judicial system more accessible to persons with disabilities is one of the of the components core Court of e-Committee, Supreme India. As Hon'ble Chairperson of the e-Committee, Dr Justice D.Y. Chandrachud exhorted High all Courts make their digital to infrastructure accessible to all, in conformity with the constitutional and statutory entitlements of people with disabilities. The letter contained a series of structural interventions for all High Courts to undertake towards enhancing digital accessibility. A significant milestone in the E-committee's efforts towards this objective- the E-committee has made all High Court websites, the websites of the E-committee and e-Courts, and the judgement search portal accessible to persons with disabilities. Digital accessibility training for the Differently Abled is a part of the eCommittee's ICT

capacity-building exercise. The digital accessibility training will be spread to all categories of disabilities among Judges and Court staff in a phased manner. In the first phase, Digital Accessibility training has been held for the visually challenged Judges and Court Staff, which is the first of its kind. Hon'ble Justice Rajiv Shakdher inaugurated the two-day programme, Judge Delhi High Court, In the august presence of Hon'ble Justice G R Swaminathan Judge High Court of Madras, Shri SKG Rahate Secretary Department of Justice, S.N.Tripathi, Director General IIPA. Shri Rajesh Aggarwal, Secretary, Department of Empowerment of Persons with Disabilities, addressed the Valedictory function. The two-day digital accessibility training was held in two separate batches for six visually challenged Judicial officers and 14 visually challenged Court staff. The training was held as

Hands-on training covering various assistive technologies like the accessible reading of court documents with a screen reader and instant reading device; accessible documentation & note-making in a digital work environment; techniques and tools for scan and creating Digital Accessible format; using the internet, judgement searching with screen readers; smartphone-based

technologies, assistive the orientation of keyboard and input in languages, Artificial regional intelligence tools and techniques for the visually impaired, digital office & Ms. R. handling usages. Arulmozhiselvi, Member (HR), eCommittee, coordinated the programme with Er Manish Verma, Director NIEPVD, and Dr. Surabhi Pandey, IIPA.

Delhi High Court Implements Bail Order Sharing e-Prison Module & Digital Court for Contested Traffic Challans







The High Court of Kerala introduced 'ePost ', the module that provides an end-to-end solution for the service of summons, notices and other documents of the High Court through the digital mode. The Department of Posts has developed a solution that integrates e-post and speed post services. As per the proposal submitted by the Postal Department, in the first phase of the project, eight nodal points would be identified in Kerala to which the communications from the High Court of Kerala would be sent as an e-post, and from there,

these communications would be sent to all post offices of Kerala Circle which would be mapped to these 8 Nodal Points. From these post offices, the printed contents of the communication would be delivered to the recipients on a D+1 Basis (The date of delivery would be the very next day of the despatch). The E-Post envelope will have a unique design with its own logo to distinguish it from other postal articles.

Application for Intra-Appeal / Revision

The Kerala High Court launched an innovative system for filing appeals with a minimal number of documents. 

Training Programs on e-filing for Advocate Clerks in Kerala






Launching of an Android Mobile Application of High Court of Tripura
