### ORDER

In granting promotion to the post of Lower Division Clerk, Grade Pay Rs. 2600/- in terms of Rule 22 (b) read with Schedule 'C' of the West Bengal District Court (Constitution of Service, Recruitment, Appointment, Probation and Discipline of Employees ) Rules, 2015, there are 9 (nine) vacant posts.

WHEREAS 61 posts of Lower Division Clerk are approved and sanctioned by the Finance Department, Government of West Bengal in this Judgeship, out of which 25% posts can be filed up by way of promotion i.e 15 posts. Already 6 posts were filed up by promotion and remaining 9 (nine) posts coming from 29th to 37th position of the 50 point Roster required to be filled up by way of promotion amongst the staff in the cadre of Group-D and Group-C (Process Server) in the ratio of 1:2 as per Notification No. 5140-J dated 20/07/2009 issued by the Judicial Department, Government of West Bengal.

AND WHEREAS the Hon'ble Supreme Court, in the case of **Tek Chand & Others -versus- Bhankra Beas Management Board** (B.B.M.S.) and others [Civil Appeal No-4882 of 2021] explained the expression "Seniority cum Merit" and by observing such principle laid down therein, the selection process for promotion has to be carried out.

AND WHEREAS in terms of Notification No. 11195, dated 22/10/1982 issued by the Finance (Audit) Department, Government of West Bengal read with Rule 63 of the West Bengal District Court (Constitution of Service, Recruitment, Appointment, Probation and Discipline of Employees) Rules, 2015, Five (05) eligible candidates are to be considered for filling up of One (01) post by way of promotion.

AND WHEREAS in terms of Notification No. 10620, dated 19/12/2000 issued by the Finance (Audit) Department, Government of West Bengal read with Rule 63 of the West Bengal District Court (Constitution of Service, Recruitment, Appointment, Probation and Discipline of Employees) Rules, 2015 "Open Performance Report" (OPR) is necessary in respect of the eligible candidates as set forth hereinbelow.
