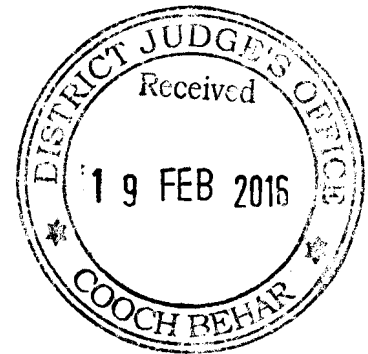

Terms and Conditions

1. The vehicle must be holding a valid registration as commercial vehicle confirming Bharat Stage -III/IV (Latest Model) and should be diesel driven.
2. The vehicle should have requisite documents viz. road permit (4 districts), registration certificate, valid insurance, tax clearance, P.C.B certification, contract carriage permit and other documents.
3. The driver of the vehicle should possess a valid commercial driving license issued by appropriate authority for the class of vehicle he is driving.
4. The owner of the vehicle shall be liable to deploy car as and when necessary.
5. The vehicle may be required to ply to Siliguri in the district of Darjeeling and other neighbouring districts for official purpose.
6. No additional payment outside accepted rate is payable for hiring a driver(s) and /or for boarding and lodging of driver(s) / or cost for repair etc., arising due to accident of the vehicle.
7. In case of any temporary withholding of service of the vehicle for repair /maintenance/ illness of driver etc., the vehicle owner, shall substitute vehicle of same quality and /or, alternate driver has to be provided for the period of withholding subject to prior intimation to authority concerned.

8. Reimbursement of POL consumed by the Vehicle @ 1 (one) litre HSD for 12 kms and 1(one) litter lubricant (Mobil) for 500 kms will be made separately to owner as per existing Govt. norms only.

9. The vehicle will be engaged on hired basis for a period of one year from the date of agreement between this authority and the owner of the vehicle.

10. The owner of the engaged vehicle shall sign an undertaking in N.J. Stamp of Rs.50/- with this authority.

11. The contract of hiring can be terminated by the Chairman, DLSA, Cooch Behar, at any time without any prior notice and assigning any reason thereof.

12. In case of any dispute, decision of authority hiring the vehicle will decide the issue and the decision shall be final.

13. Daily rate of duty will be 10 hours.

14. In no case hiring charges will be more than the rate approved by the Government through No.3565-WT/3M-81/98 dt.24-11-2008 of Transport Deptt, Govt. of WB.

15. The authority reserves the right to except any of quoted rate(s) suitable for users, and also reserves the right to except or cancel any or all quotations(s) without assigning any reason thereof.
