ORDER

The Governor is hereby pleased to say that the proposal for creation of 31 (thirty-one) posts of Court Manager on regular basis, 03(three) for the High Court, Calcutta including 02(two) Circuit Benches of High Court and 28(twenty-eight) for Districts was under consideration of the Government of West Bengal.

After careful consideration the Governor is pleased further to accord sanction to the above proposal i.e. creation of 31 (thirty-one) regular posts of Court Manager in Pay Level 18 (Rs. 68,400-Rs. 1,76,200) in revised pay structure under ROPA, 2019 in the following manner :-

- i) 03(three) for the High Court Calcutta and two Circuit Benches of High Court,
- ii) 28(twenty-eight) for Districts.

The charges will be met from the suitable Head of Account under Demand No. 34.
