

Vide Hon'ble High Court's Letter Number 9275/Main-B/Admin(A-3)/Allahabad dated 06.07.2024, it is informed that in the meeting dated 08.05.2024 of the State Government, the following resolution was passed in the matter:-

Hence, in pursuance of the above direction the Additional Chief Judicial Magistrate, Court No.-I, Mainpuri Smt. Vibha Dhara, is hereby nominated for the trial and disposal of the cases related to embezzlement in Co-operative Societies Act.




