Order No. 41 /2024

In obedience to the direction contained in *Letter No. 146/Admn. Misc. Dated 29.02.2024* of the *Hon'ble Jharkhand High Court*, the names of provisionally selected candidates as well as the waiting list candidates for the appointment to the post of *Group C (Driver) in the pay scale of Rs. 19900-63200, pay level-2* and *Group D post of (Peon) in the pay scale of Rs. 18000-56900, pay level-1* in the light of advertisement no. 01 /2023 in Civil Court, Palamau, is hereby allowed to be published on the website as well as on the notice board.

*Four (4) Candidates* have been selected for the regular post of *Group C (Driver) in the pay scale of Rs. 19900-63200, pay level-2* and *Fourty Seven (47) candidates* have been selected for the regular post of *Group D (Peon) in the pay scale of Rs. 18000-56900, pay level-1* based on their marks obtained category wise. Candidates have been selected keeping in view the reservation policy of the Government including the reservation policy for person with disability. A waiting list of candidates has also been prepared according to the merit list.

Let the Appointment letter be issued to the selected candidates (except waiting list candidates) with the direction to join their post on or before **4th April 2024** and candidates shall produce all the original documents for verification such as educational certificates including matriculation in proof of their age, Medical fitness certificate issued by the Civil Surgeon and Caste certificate, Domicile / Residential certificate (in case of reserved categories) issued by the competent authority of State of Jharkhand. ***Selected Candidates can also obtain their Appointment Letter in person from the office of Registrar, Civil Court, Palamau in case they do not receive appointment letter within time.*** Candidates are also directed to file an affidavit that he/she was not convicted earlier in any criminal case. Apart from that, selected candidates are directed to file an affidavit at the time of their joining with a declaration in a prescribed format for non-acceptance of dowry. The photograph, signature and handwriting of the selected candidates must be verified at the time of joining from the application form submitted by him/her.

The validity of the waiting list shall be as per the rule. The list of selected candidates as well as the waiting list as annexed, which has been approved by the Hon'ble Jharkhand High Court shall form part of this order.

No T.A. and D.A. shall be admissible to the newly appointed candidates for joining their post. Their service shall be on probation for a total period of two years within a continuous period of three years.


