Administrative Order No. 143 / 2025

Vide Hon'ble High Court's letter no. 9275/Main-B/Admin. (A-3)/ Allahabad
Dated: 06.07.2024, following resolution of the meeting dated 08.05.2024 of the
State Government was communicated for compliance and the same is being
quoted as under-

बी (एडिमन-ए-३) दिनांक ०९.०७.२०२१ के आलोक में सम्यक विचारोपरान्त यह निश्चित हुआ कि
अधिसूचना संख्या १००२/सात-न्याय-२-०६-२१६/७७, दिनांक २२.०९.२००६ में दी गयी व्यवस्था
को ही बनाये रखा जाय तथा उक्त अधिसूचना दिनांक २२.०९.२००६ के अनुसार प्रत्येक जिले में
तैनात द्वितीय ज्येष्ठतम अपर मुख्य न्यायिक मजिस्ट्रेट के न्यायालय ही विशेष अनुसंधान शाखा
(सहाकारिता) द्वारा विवेचित वार्दों के विचारण हेतु अभिहित न्यायालय रहेंगे।”

Therefore, in pursuance of the State Government's resolution dated
08.05.2024, vide administrative order dated 09.07.2024 passed by my learned
Predecessor, 2nd Senior most Additional Chief Judicial Magistrate of this
Judgeship Sri Kuwar Rohit Anand was nominated/authorized for trying the
cases, investigated by the investigating agency "विशेष अनुसंधान शाखा (सहाकारिता)".

Consequent upon transfer & posting of the Judicial Officers of the cadre
of Civil Judge (Senior Division) in annual chain 2025, now Smt. Nitika Rajan
happens to be 2nd senior ACJM of this Judgeship.

Therefore, abiding by the provisions contained in the above stated
resolution dated 08.05.2024 of the State Government, Smt. Nitika Rajan is
hereby nominated/authorized for trying the cases, investigated by the
investigating agency "विशेष अनुसंधान शाखा (सहाकारिता)" with immediate effect.

The learned Chief Judicial Magistrate, Azamgarh shall take steps for
assigning all the cases fall in the said category to the court presided by the
above cited learned Presiding Officer.

Inform all concerned accordingly for compliance. Let copy of the order be
sent to the Bar Association for information.
