It is notified for all concerned that no recruitment of Court staff has been done during last two years 2021 and 2022. Year ending of 2023 is offing. As such vacancies of Court staff presently are 60.

Under such circumstances, immediate steps are required to be taken for filling up such huge vacancies without causing further delay.

Prior to such initiation of recruitment process, long pending promotion of clerical staff is required to be exhausted for calculation of actual vacancies as per existing recruitment rules.

Accordingly and to expedite the process of long pending promotion of Clerical staff the "Promotion-cum-Gradation List Preparation Committee" since formed vide order No. 176 dated 11.07.2023 is being extended by adding the Additional District & Sessions Judge, 1st Court, Raiganj as a Member of that Committee.


