The District Nazir be directed to take necessary measures for issuance of a cheque amounting to Rs. 5,000/- (Five Thousand only) to meet the expenses for refreshment of the attendance of meeting of the D.R.C. and D.R.S.C. and procurement of necessary accessories in connection with the recruitment process from the recruitment fund.
