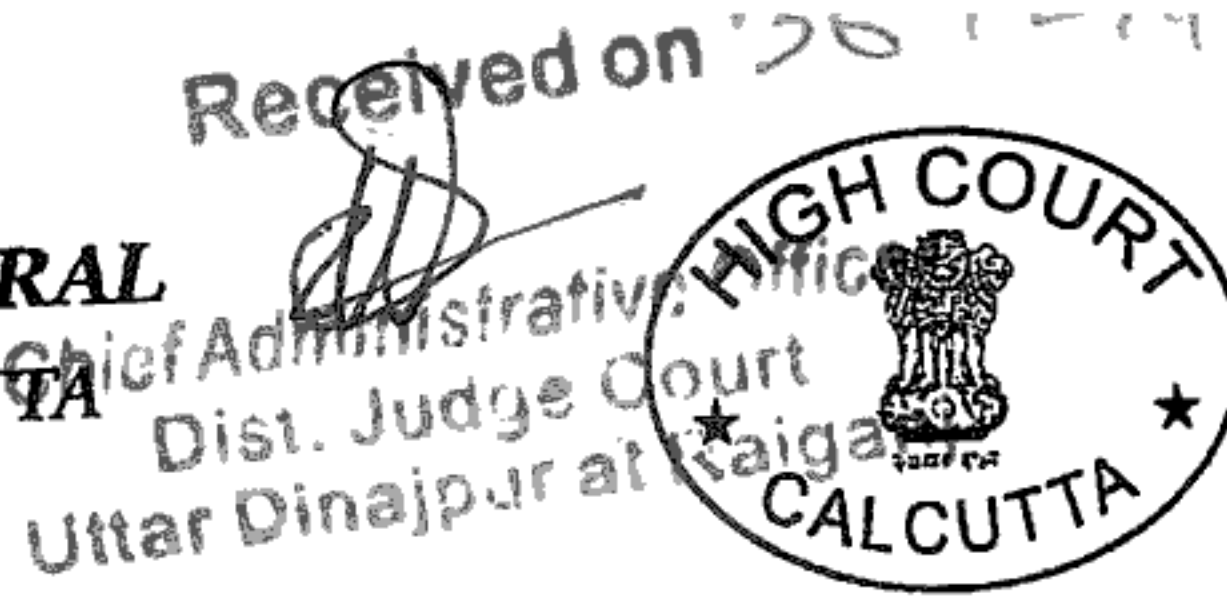

Apropos of the above, I am directed to inform that Hon'ble Supreme Court of India is going to organize a Special Lok Adalat from 29th July, 2024 to 3rd August, 2024 for the matter pending before it. Under such circumstances, all the Chief Judges/District Judges cum Chairpersons of DLSAs are requested to make adequate publicity about the Special Lok Adalat to be held in the Supreme Court of India in their respective jurisdiction in the following manner:

- (a) To publish notice in the website of their respective district;
- (b) The publication may be made through You Tube Channel of Districts and SLSA;
- (c) By circulating the notice to the President and the Secretary of the respective Bar Association by the Chairman, DLSA concerned;
- (d) To make effective services of Notice of Special Lok Adalat on the parties with the assistance of PLVs, Police personnel and or through e-mail and WhatsApp messages concerning pending cases from their respective jurisdiction before the Hon'ble Supreme Court to ensure participation of the parties before the ensuing Lok Adalats.

All the Chairpersons, DLSAs are requested to make necessary arrangements for pre-Lok Adalat sitting and aiding the parties.
