Administrative Order No 06/XV-6-2011/Local Holiday/Dated: Basti: 4January, 2024 Order

According to the instruction given in point no. 3 of the notes of holiday list (calendar) sent by the Hon'ble High Court in the subordinate courts for the year 2024, the District Judge has been authorized to declare five days local holidays in the subordinate courts in consultation with the District Magistrate.

In this regard, list of the holidays (calendar) received from the office of the District Magistrate, Basti and the Circular letter No. 68/Das-E-4/ dated 26.07.1980 of the Hon'ble High Court regarding the declaration of holiday was observed and discussion were made with the District Magistrate, Basti. In the said circular of the Hon'ble High Court, there is a direction to declare a holiday while maintaining parity with the holiday of the Revenue Courts.

In holiday list (calendar) received from the District Magistrate's office Basti for use in the year 2024, public holiday on the occasion of Rakshabandhan on 19.08.2024 in schedule-1 & restricted holiday have been declared on occasion of Makar Sankranti on 15.01.2024 in schedule-3 and local holidays have been declared on occasion of Holi on 26.03.2024, Jamaat-ul-vida (Alvida)/last Friday of Ramjan on 05.04.2024 and Shivratri/Gauri Pujan (Kavad) on 02.08.2024 in schedule- 6. No holiday has been declared on the said dates in the holiday list received from the Hon'ble High Court.

In accordance with the instruction given in point no. 3 of the notes of holiday list (calendar) received from the Hon'ble High Court and Circular letter No. 68/Das-E-4/ dated 26.07.1980 of the Hon'ble High Court, local holidays may be declared on the occasion of festivals of local importance.

Therefore, keeping in view the public holidays declared by the Government, the local holidays declared by the District Magistrate, Basti and other holidays of local importance, In exercise of the powers contained in the Manual of Government Orders (Revised Edition 1981) Para 247 and point no. 3 of the notes of holiday list (calendar) received from the Hon'ble High Court, local holidays in this judgeship are declared as follows-

In the list of holidays declared by the Hon'ble High Court for the year 2024 for the subordinate courts, 24.03.2024 (Sunday) on the occasion of Holi and 13.10.2024 (Sunday) on the occasion of Dushahra is a public holiday. It is mentioned in point no. 7 of the notes of holiday list (calendar) received from the Hon'ble High Court that in case any of the National or other holidays mentioned in the Calendar falls on Second Saturday or on a Sunday, it will be up to the District Judge to declare in its place additional days as holidays.

As per instruction given in point no. 7 of the notes of holiday list (calendar) of the Hon'ble High Court, in lieu of holidays falling on Holi on 24.03.2024 (Sunday) and on Dushahra on 13.10.2024 (Sunday) an additional holiday of 02 days may be declared in this judgeship.

No holiday has been declared in holiday list of Hon'ble High Court on the occasion of Deepawali on 31.10.2024 and on the occasion of Guru Nanak Jayanti/Kartik Purnima on 15.11.2024. In the schedule of holiday received from the office of District Magistrate Basti in year 2024, Deepawali on 31.10.2024 and Guru Nanak Jayanti/Kartik Purnima on 15.11.2024 have been declared as public holiday.

Keeping in view the importance of the above festival, it is appropriate to declare additional days as holidays on 31.10.2024 on occasion of Deepawali and on 15.11.2024 on occasion of Guru Nanak Jayanti/Kartik Purnima.

Therefore, in accordance with the instructions given in point no. 7 of the notes of holiday list (calendar) of the Hon'ble High Court, the holiday will be declared on 31.10.2024 on occasion of Deepawali in lieu of the holidays on 24.03.2024 (Sunday) on occasion of Holi, the holiday will be declared on 15.11.2024 on occasion of Guru Nanak Jayanti/Kartik Purnima in lieu of the holidays on 13.10.2024 (Sunday) on occasion of Dushahra as an additional days in this judgeship.

All the courts and offices of this judgeship will remain closed on the above dates and hearing of the cases (if any) fixed on the above dates will be done on the next working day.
