## Administrative Order No.3857XV-6-2011/Local Holiday/Dated: Basti: 10 August, 2022 Order

- 1- In the list of holidays declared for the year 2022 by the Hon'ble High Court for the subordinate courts, on the occasion of Id-ul-Zuha, 10.07.2022 (Sunday) has been declared as a holiday. It is mentioned in point no. 7 of the notes of holiday list (calendar) received from the Hon'ble High Court that in case any of the National or other holidays mentioned in the Calendar falls on Second Saturday or on a Sunday, it will be up to the District Judge to declare in its place additional days as holidays.
- 2- In the calendar issued by the Hon'ble High Court for the subordinate courts, the holiday of Id-ul-Zuha on 10.07.2022 (Sunday) has been marked with the asterisk (\*) and in point no. 1 of the notes of holiday list (calendar), it has been directed by the Hon'ble High Court that the dates marked with asterisk (\*) can be re-fixed according to the local visibility of the moon.
- 3- Earlier, local holidays and other holidays (in place of holidays falling on second Saturday and Sunday) have been declared by the undersigned in this judgeship vide the Administrative Order No. 20/XV-6-2011/Local Holiday/ dated 11.01.2022. But due to the local visibility of the moon, at that time, no holiday was declared in place of the Id-ul-Zuha holiday falling on 10.07.2022 (Sunday).
- 4- The Office has reported that as per the local visibility of the moon, the festival of the Id-ul-Zuha was celebrated in this district on 10.07.2022 (Sunday). Therefore, in compliance of the instruction given in point no. 7 of the notes of holiday list (calendar) of the Hon'ble High Court, in lieu of holidays falling on Id-ul-Zuha on 10.07.2022 (Sunday) an additional day may be declared as holidays in this judgeship.
- 5- In holiday list received from the Hon'ble High Court, no holiday has been declared on the occasion of Govardhan Pooja on 26.10.2022. In the schedule of holidays received from the office of District Magistrate Basti in year 2022, Govardhan Pooja on 26.10.2022 have been declared as public holiday in Basti District.
- 6- Hence, it would be appropriate to declare an additional day as holiday on the occasion of Govardhan Pooja on 26.10.2022.
- 7- Therefore, in accordance with the instructions given in point no. 7 of the notes of holiday list (calendar) of the Hon'ble High Court, a holiday is declared on 26.10.2022 on the occasion of Govardhan Pooja in this judgeship in lieu of the holiday declared on 10.07.2022 (Sunday) on the occasion of Id-ul-Zuha.
