1- The Hon'ble High Court has been pleased to pass the following order on 17.03.2022 vide its letter no. 3254/Admin(E-I)XC-27/Dated: Allahabad: 17.03.2022-

- 3- Earlier, in compliance of the instruction given in point no. 3 of the notes of holiday list (calendar) received from the Hon'ble High Court, on the occasion of Holi, a local holiday was also declared by the undersigned on 19.03.2022 vide Administrative Order No. 20/XV-6-2011/Local Holiday/ dated 11.01.2022.
- 4- Since, on account of Holi, 19.03.2022 has been declared a public holiday by the Hon'ble High Court in the Courts subordinate to the High Court of Judicature at Allahabad and a local holiday has also been declared by the undersigned on 19.03.2022 vide Administrative Order No. 20/XV-6-2011/Local Holiday/ dated 11.01.2022. So, it is necessary to cancel the local holiday declared by the undersigned on 19.03.2022.
