

OFFICE OF THE DISTRICT JUDGE, BASTI.Administrative Order No. *137* /2024/ Dated: Basti: *24* April, 2024**ORDER**

Due to annual transfer of Judicial Officers from this judgeship to another district, it is urgent need to make arrangements for in-charge of various courts running in this judgeship.

Therefore, in supersession of my all previous orders regarding the in-charge of the courts, for smooth running of the judicial and administrative works of the courts, the following arrangement are being made for the in-chargeship of various courts running in this judgeship with immediate effect-

2- Under the above arrangement, if the officer-in-charge of the Additional District and Sessions Judges court is not present, then the urgent and routine work of the said court will be done by the next officer-in-charge and if all the officer-in-charge are not present, then the urgent and routine work of the courts will be done by the Additional District and Sessions Judge/District Judge present at Headquarters.

Judicial Magistrate/Additional Civil Judge (S.D.) Court No. 11 Basti mentioned in table 3 are not present, then in such a situation, all the urgent and routine works of **Civil Nature** will be performed by the Civil Judge (S.D.) Basti.

3- If the presiding officers of all the courts of Civil Judge (S.D.)/Additional Civil Judge (S.D.) cadre mentioned in table 2 and table 3 are not present, then in such a situation, all the urgent and routine works of **Civil Nature** of all the said courts will be performed by the Junior Most, Additional District & Session Judge Basti present at Headquarters.

4- If the presiding officers of all the courts of Chief Judicial Magistrate/Additional Chief Judicial Magistrate/Judicial Magistrate cadre mentioned in table 3 are not present, then in such a situation, all the urgent and routine works of **Criminal Nature** of all the said courts will be performed by the Junior Most, Additional District & Session Judge, Basti present at Headquarters.

Special Notes:-



2- It is expected from all the presiding officer of this judgeship that in case of being an officer-in-charge of any court, they will perform all the urgent and routine works of that court with interest and devotion. So that the litigants do not face any kind of difficulty. All the presiding officer of this judgeship are also expected that they must inform officer-in-charge of their court whenever they take casual leave or any kind of leave or take permission to leave the Headquarters.

Inform all the concerned accordingly.


