महोदय

उपरोक्त विषयक संदर्भ में सादर अवगत कराना है, माननीय सर्वोच्च न्यायालय द्वारा रिट याचिका सं0 182/2001 में मुम्बई में सन् 1992-93 के दंगों/बम विस्फोटों के पीड़ितों के वारिसों को प्रलंबित आर्थिक सहायता प्रदान किये जाने हेतु निर्देशित किया गया था, तथा पारित निर्देशों के अनुपालन हेतु महाराष्ट्र राज्य विधिक सेवा प्राधिकरण के सदस्य सचिव की अध्यक्षता में एक समिति का गठन किया गया है।

दिनांक 19.12.2023 को उक्त समिति की बैठक में यह निर्णय लिया गया कि दंगों/बम विस्फोटों में मृत / लापता व्यक्तियों (छायाप्रति संलग्न) के वारिसों को प्रलंबित आर्थिक सहायता प्रदान किये जाने के संबंध में समाचार पत्रों के माध्यम से सार्वजनिक अपील (छायाप्रति संलग्न) जारी की जाये तािक संबंधित व्यक्तियों को आर्थिक सहायता प्राप्त हो सके।

Appeal to the Legal Representatives of Dead/Missing Victims of 1992-93 Riots/Bomb Blasts in Mumbai

Hon'ble Supreme Court has issued the order regarding the '1992-93 Riots/Bomb blasts in Mumbai in' its Civil writ petition No. 182/2001 (vide order dated 4th November 2022) regarding granting the ex-gratia to the Legal Relatives of the Dead/Missing persons and to whom those who have received the Ex-gratia belatedly are directed to pay interest on such grant as per the Government of Maharashtra Resolution RLF/5992/pr.kr.276/M-3, dated 8th July 1993 & RLF/4997/pr.kr.4/M-3,[cell], dated 22nd July 1998, a committee has been constituted under the chairmanship of Hon'ble Member Secretary, Maharashtra State Legal Services Authority, Mumbai. As per the discussion held in the committee meeting on dated 18/03/2024, 02/04/2024 and 30/04/2024, it was directed to this office to publish an appeal for the public with the list of deceased persons from the 1992-93 Riots/Bomb blasts regarding the delayed payments to the LRs of the concerned deceased persons.

A list of 105 deceased persons whose Legal Relatives are untraceable despite several efforts made by the authorities to find them for granting Ex-gratia or delayed sums regarding the compensation is published at following websites https://mumbaicity.gov.in/, https://mumbaicity.gov.in/, and https://legalservices.maharashtra.gov.in/.

The respective legal heirs of the listed 105 deceased persons are hereby requested to approach the below-mentioned address within One (1) Month from the date of publication of this notice with necessary documentation and identity proofs about Financial Assistance from the Government.
