ADVERTISEMENT

In pursuance to Letter No. HC.VII-33/2018/7257/A, Dated: 25.08.2022 of the Hon'ble Gauhati High Court, applications are invited from the eligible Candidates for filling up the following posts for upcoming Fast Track Special Court (ePOCSO Courts) in the Establishment of the District & Sessions Judge, Bongaigaon on contractual basis/hiring. The hiring of the staff for the below mentioned post is purely on contractual basis and the selected candidates/staffs shall join on the day of inauguration of the ePOCSO Courts in the Bongaigaon District and their tenure of the post are for the current financial year or till the scheme is continued by the Government at the Centre and State.

Eligibility

Sl. No	Posts	Qualifications
01	Technical Assistant	The Candidates must be a graduate holding a BCA degree or equivalent degree from a recognized university
02	Stenographer (Grade-III)	The Candidates must <u>have</u> passed HSSLC (Higher Secondary) and must have Diploma in English short hand with minimum 80 words per minute.
03	Driver	The Candidates must <u>have</u> passed Class VIII standard having valid LMV Driving License. Those who have passed HSSLC or above shall be ineligible to apply for the posts.
04	Peon	Minimum qualification is Class VIII passed and those who have passed HSSLC or above shall be ineligible to apply for the posts. Candidates possessing special skill may be given preference.

Terms and Conditions

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Candidates must have registered their names in the Employment Exchange and the Registration numbers along with date must be mentioned in their applications.
3. Candidates serving in Govt. Department should submit their application through proper channel.
4. If any candidate is found to have suppressed his educational qualifications or given wrong information, at the time of applying for job or later on, his candidature shall stand rejected without any information to him with immediate effect and shall also be liable to Criminal Prosecution as per Law.
5. Candidates must not be less than 18 years or more than 40 years of age on the last date of submission of application. The relaxation of age shall be applicable as per government rules
6. The application with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste, Valid Employment Exchange Registration Card, Driving License (for the post of Driver), Experience Certificate & Character Certificate along with 3 (three) copies of recent passport size photographs, duly signed by the candidate on the reverse side, should reach the office of the undersigned.
7. **Candidates, who have passed HSSLC or above shall be ineligible to apply for the post of Driver and Office Peon.**
8. The applicant must have a **valid Profession/Transport Driving License issued by competent Authority (for the post of Driver).**
9. The eligible candidates for the post of Driver shall be required to appear for skill test, followed by viva-voce.
10. The applicants shall mention their Mobile Numbers in the application without fail.
11. All the applications must reach the undersigned within 12 days of publication of this advertisement in the official website of the Bongaigaon District Judiciary. No application will be entertained after the last date, The appointing authority shall not be responsible under any circumstances for any postal delay.
12. The list of eligible candidates along with specific dates of skill test and interview shall be uploaded in the Official website of Bongaigaon District Judiciary in due course (<http://bongaigaonjudiciary.gov.in>). **No separate call letters will be issued.**
13. The final selection for the post of Technical Assistant and Office Peon will be made on the basis of marks obtained by the candidates in Interview/Skill test/Viva-voce only.
14. The final selection for the post of Driver will be made on the basis of the total marks obtained by candidates in skill/driving test and interview/Viva-voce only.
15. Interview Center: Bongaigaon (Date & Venues will be informed in the Official Website).
16. No TA/DA will be admissible to the candidates for attending the Skill Test/Interview Process.
17. Application received late or without proper supporting documents or unsigned or incomplete will be summarily rejected.
18. Canvassing directly or indirectly shall disqualify a candidate.
19. The Application shall be addressed to the **District and Sessions Judge, Bongaigaon.**






