Applications were invited for filling up of 1 (one) no. of vacant post of Office Peon (permanent) under the District & Sessions Judge Establishment, Bongaigaon vide advertisement dated 05.08.2020 in the Asomiya Pratidin newspaper. A total of 301 nos. of applications were received out of which 97 applicants are found eligible for appearing in the Interview/Viva-voce to be held on 18.09.2021 and 19.09.2021. No. from 68 to 97 are directed to appear for the Interview/Viva-voce to be held on 19.09.2021 from 1:30 PM onwards at the Office of District & Sessions Judge, Bongaigaon.

Instructions for Interview/Viva-voce

1. All candidates are to report at the venue for Interview/Viva-voce 45 minutes before time.
2. All the candidates are directed to bring their testimonial in original including identity proof without fail for verification.
3. No Separate call letter shall be issued.
4. No TA/DA will be admissible to the candidates for attending the Interview/Viva-voce.
5. The decision of the Selection Board in all matters would be final and binding on the candidates.
6. Canvassing in any form for selection including change of date, time, venue etc. shall be treated as disqualification.
7. The candidates appearing in the interview/viva-voce shall have to make a declaration regarding his educational qualification, and details of offspring (children) as per the format to be supplied to the candidates at the time of interview/viva-voce.




