In pursuance to the Notification No.28, dated 22<sup>nd</sup> May 2020 issued by Hon'ble Gauhati High Court regarding '**Restricted Court Functioning**' with '**Staggered Roster**' as well as, in pursuance of the Order passed by Hon'ble the Chief Justice, on 15<sup>th</sup> day of May 2020, in this regard, the following Roster with time slots for Virtual Courts is hereby prepared for the functioning of district courts at Bongaigaon and its Sub-Division at Abhayapur until further orders. - (iii) Virtual Court No.3 (Remote Point):- Courtroom of the Court of Additional Chief Judicial Magistrate at Bongaigaon.
- (iv) Virtual Court No.4 (Remote Point):- Courtroom of the Court of Munsiff at Bongaigaon.

**(B) Virtual Courts at Abhayapuri:-**

- (i) Virtual Court No.1 (Remote Point):- Courtroom of the Court of Addl. District & Sessions Judge, FTC, at Abhayapuri.
- (ii) Virtual Court No.2 (Remote Point):- Courtroom of the Court of Sub Divisional Judicial Magistrate (M) at Abhayapuri.
