Heard Mr. T. J. Mahanta, learned Standing Counsel, Gauhati High Court, who has been appointed as *amicus curiae* in this proceeding.

2. This *suo moto* writ petition has been taken up in terms of the direction issued by the Hon'ble Supreme Court in WP(C) No.699/2016 on 16.09.2020 directing constitution of a Special Bench and, accordingly, the present Bench has been constituted consisting of the Chief Justice (Acting) and Hon'ble Mr. Justice Mir Alfaz Ali.

**3.** Issue notice to all the respondents, returnable in two weeks.

**4.** Mr. D. Mazumdar, learned Additional Advocate General, Assam accepts notice on behalf of respondent Nos.1, 5, 9 and 13; whereas Mr. A. D. Choudhury, learned Additional Advocate General, Mizoram accepts notice on behalf of respondent Nos.3, 7 and 11. Mr. A. Chandran, learned Additional Senior Government Advocate, Arunachal Pradesh appears for respondent Nos.4, 8 and 12 and Ms. T. Khro, learned Government Advocate, Nagaland appears for respondent Nos.2, 6 and 10.

**5.** While issuing notice, this Court has felt it appropriate to refer to certain background facts which may be relevant in making all the respondents aware of the significance and importance of this Special Bench constituted for the purpose of monitoring cases.

**6.** It may be mentioned that the Hon'ble Supreme Court has taken up the writ petition, WP(C) 699/2016 in which certain reliefs have been sought for, including to ensure that persons with criminal background or convicted of offences are barred from contesting elections in the Legislative Assemblies as well as in the Parliament or becoming office-bearers of political parties.

7. In connection with the aforesaid proceedings, the Hon'ble Supreme Court had sought for detailed reports from all the High Courts as regards pendency of criminal trials against persons involving sitting legislators/ex-legislators and to take necessary steps for streamlining the trials going on for expeditious disposal in connection with which the Hon'ble Supreme Court also had requisitioned the valuable assistance of an *amicus curiae*, Sri Vijay Hansaria, Senior Advocate, who had pointed out certain factors impeding speedy trial, which are reflected in paragraphs 5 to 9 of the order passed by the Hon'ble Supreme Court on 16.09.2020.

**8.** Learned *amicus curiae* had also made certain suggestions for streamlining and expediting trials involving political personalities for which steps have to be taken by the respective High Courts. There are also suggestions for appointing Nodal Prosecution Officers and Public Prosecutors and also for giving priorities by the Forensic Science Laboratories in furnishing reports relating to such trials and also for providing 'Safe and Secure Witness Examination Room' in the Court complexes with availability of the internet facility for the purpose of recording of evidence of the witnesses through Video Conferencing and setting up of Rules for Video Conferencing, etc.

**9.** In the order passed by the Hon'ble Supreme Court on 16.09.2020, the submissions made by learned Solicitor General of India have also been recorded. The learned Solicitor General of India had suggested that State Governments should provide necessary infrastructure within a month for which the Central Government has already granted funds.

**10.** Learned Solicitor General of India had also suggested that Central Agencies like the CBI and the Enforcement Directorate will pursue the matters effectively and they shall ensure that any pending investigation or trial will reach its logical conclusion at the earliest.

**11.** The Hon'ble Supreme Court taking cognizance of the earlier decision of the Supreme Court in *Asian Resurfacing of Road Agency Pvt. Ltd Vs. CBI, 2018 (16) SCC 299,* also impressed upon the Courts for expediting disposal of the trials and also for vacation of interim orders coming in the way of expeditious disposal.

**12.** The Hon'ble Supreme Court also issued a number of directions to the learned Chief Justices of the High Courts for preparing action plans and to take such other measures as mentioned in the order.

**13.** While awaiting necessary directions from the Hon'ble Supreme Court in the aforesaid writ petition, we are of the view that the State respondents will take all necessary and appropriate steps in the pending criminal trials which would help in expediting the same.

**14.** These observations are made to contextualize the very purpose of this Special Monitoring Bench which will be convened with regular intervals.

**15.** A copy of this order along with all the papers/documents forming part of this *suo motu* petition be furnished to all the learned counsel appearing for the respondents.

**16.** List the matter again on 14.10.2020 by showing the names of all the learned counsel for the respondents.
