**NOTIFICATION NO. 61**

Dated: Guwahati, the 5<sup>th</sup> September, 2020

The Committee for taking decisions for opening the Courts, or imposing restrictions on Court functioning of the Gauhati High Court (Principal Seat) as well as its outlying Benches and Subordinate Courts of Assam, Nagaland, Mizoram and Arunachal Pradesh, in its meeting held on 02.09.2020 with the Principal Secretary to the Government of Assam, Health and Family Welfare Department, deliberated the feasibility of resumption of physical hearing in the Courts of Assam. The Standard Operating Procedure (SOP) recommending necessary health guidelines of physical Courts, is under process of preparation in consultation with the Health and Family Welfare Department, Government of Assam.

The Subordinate Courts of Assam has already been instructed to take necessary steps for installation of fittings and fixtures in the Court rooms for resumption of physical Courts, besides taking other appropriate measures for the safety of all concerned.

In accordance with recommendation of the Committee, till finalization of the SOP and installation of the necessary infrastructure for resumption of physical hearing in the Courts of Assam, the guidelines contained in Notification No. 53 dated 31.07.2020 shall be continued.
