VIII/40/R/PT/SSRC/2020-2022/ dated 08/04/2022, wherein the minutes of the State Security Review Committee (SSRC) held on 21-01-2022 & 31-01-2022 has been circulated. The Govt. has directed to comply regarding security coverage of the Hon'ble Judges of the District as per latest guidelines. The District & Sessions Judge has been categorized as Y (Armed Escort or Armed House Guard & PSO) and Addl. District & Sessions Judge and CJM as X (one PSO).
