further to amend the Factories Act, 1948, in its application to the State of Assam.

Preamble

Central Act Whereas it is expedient further to amend the Factories Act, No. 63 of 1948, hereinafter referred to as the principal Act, in its 1948 application to the State of Assam, in the manner hereinafter appearing;

It is hereby enacted in the Seventy-first Year of the Republic of India as follows:-

extent and commencement 1.

- (1) This Act may be called the Factories (Assam Amendment) Act, 2020.
- (2) It extends to the whole of the State of Assam.
- (3) It shall be deemed to have come into force on the Assam 30<sup>th</sup> day of June, 2020, the date on which the Ordinance No. IV of 2020 Factories (Assam Amendment) Ordinance, 2020, came into force.
- In the principal Act, in section 2, in clause (m),-2.

(i) in sub-clause (i), for the word "ten" appearing in between the words "whereon" and "or", the word "twenty", shall be substituted;

(ii) in sub-clause (ii), for the word "twenty", appearing in between the words "whereon" and "or", the word "forty", shall be substituted;

Amendment of In the principal Act, in section 85, in sub-section (1), in 3. clause (i), for the words "ten" and "twenty", the words section 85 "twenty" and forty" respectively, shall be substituted.

> (1) The Factories (Assam Amendment) Ordinance, 4. 2020, is hereby repealed.

> > (2) Notwithstanding such repeal anything done or any action taken under the Ordinance, so repealed, shall be deemed to have been done or taken under the corresponding provisions of this Act.
