

With reference to the subject cited above, I am directed to inform you that the Assam Government in a bid to transform the functioning of the administration into more efficient manner, is undertaking initiatives to turn the Assam Secretariat into a paper less office through mandatory e-office module under the File Management System wherein all physical files will be converted to e-files and movement of the files in paperless form.
