

Fresh from the Bench

Shaji Poulose v Institute of Chartered Accountants of India, 2024 INSC 451

Tax Audits by Chartered Accountants per year

In its judgment dated 17 May 2024, a two-judge bench comprising **Justice B V Nagarathna** and **Justice Augustine George Masih** upheld a rule (para 6.0 of Chapter VI of the Council Guidelines No. 1-CA(7)/02/2008 dt. 08/08/2008 issued by the Institute of Chartered Accountants of India (ICAI) which barred the Chartered Accountants (CA) from accepting more than the 'specified number of tax audit assignments' (at present, the upper limit is set at 60) in a financial year. The Court held that the rule is not violative of the fundamental right to practice profession

guaranteed under Article 19(1)(g) and justifiable under Article 19(6) of the Constitution. The Court further held that the clause will be deemed to be effective from 1 April 2024. The Court quashed the disciplinary proceedings initiated against the members (petitioners) for violation of the clause based on the *doctrine of legal uncertainty*. The Court while upholding the rule held that the ICAI would be at liberty to enhance the number of audits a CA can undertake under Section 44AB of the Income Tax Act, 1961.

Application of the principle of res judicata

In its judgment dated 17 May 2024, a three-judge bench comprising of Justice Surya Kant, Justice Dipankar Dutta and Justice Ujjal Bhuyan, observed in a batch of cases pertaining to land acquisition initiated under the Land Acquisition Act of 1986, that the principle of *res judicata* may not strictly apply to situations where public interest is at stake. The Appellant had filed a Special Leave Petition (SLP) to set aside the acquisitions in light of the change in settled law, which was opposed by the Respondent stating that the issue had already been disposed by the

Court. The Court held that where a question under adjudication is one purely of law and it relates to the jurisdiction of the Court or a decision of the Court sanctioning something which is illegal, then an affected party will not be precluded from challenging the validity of such order due to the rule of *res judicata* for a rule of procedure cannot supersede the law of the land. The Court held that a more flexible approach ought to be adopted by courts, recognising that certain matters transcend individual disputes and have far-reaching public interest implications.

Kasthuripandian S v Rbl Bank Limited

Transfer of a case for the offence of dishonour of cheque

In its order dated 24 June 2024, a two-judge vacation bench comprising Justice A S Oka and Justice Rajesh Bindal observed that transfer of a case for the offence of dishonour of cheque under Section 138 of the Negotiable Instruments Act, 1881, cannot be sought at the instance of the accused. The vacation

bench dismissed a transfer petition sought at the behest of the accused involved in the offence under Section 138 of the Negotiable Instruments Act, 1881. Justice Oka remarked that while the accused can seek exemption from personal appearance, a transfer petition cannot be filed by him/her.

Costs imposed for suppressing material facts

In its order dated 25 June 2024, a two-judge vacation bench comprising **Justice A S Oka** and **Justice Rajesh Bindal** deprecated the practice of suppressing material facts by lawyers in Special Leave Petitions. The Court imposed a cost of Rs. 25,000 on the petitioners and expressed that such measures were

necessary. The Court was hearing a challenge against the interim order dated 20 March 2024 of the Delhi High Court by the All India EPF Staff Federation. The main grievance of the petitioner was that without granting interim relief, the case was adjourned to September.

Elevation of Judge can not be termed as anticipated vacancy

In its order dated 25 June 2024, a two-judge vacation bench comprising Justice Manoj Misra and Justice S V N Bhatti dismissed a petition filed by a judicial officer seeking promotion to a vacancy that arose after the elevation of a District Judge to the High Court. Refusing to interfere with the judgment of the Himachal Pradesh High Court, the Supreme Court observed that a vacancy arising out of the elevation of a judge could never be termed

as an anticipated vacancy. A vacation bench was hearing a plea filed by a judicial officer in the Himachal Pradesh Judicial Services. In the impugned order, the High Court had observed that merely because a wait list was being maintained, the Petitioner (who was on the waitlist) could not have been appointed against the vacancy that arose on the elevation of a Judge.

Vacation Bench during the month of June

Ensuring speedy justice, the Judges of the Supreme Court have been hearing cases on a daily basis during the vacation bench. For the first time in the history of the Supreme Court, three vacation benches in a day and an overall 20 benches were set up during the summer vacations, 2024. The average disposal of matter preceding 2023 has been around 461 cases per vacation. In the 2023 summer break, the Supreme Court disposed of 751. Whereas, the disposal rate significantly increased to 1170 for the year 2024.

The Supreme Court Judges ensure that justice is dispensed round the clock even during the vacation period. Judges of the Apex institution work tirelessly throughout the year. Speaking on one occasion the Chief Justice of India, Dr D Y Chandrachud highlighted that-

Court from 10:30 am to 4 pm daily, when we handle between 40 and 60 cases. The work we do between 10:30 am to 4 pm is a fraction of the work we do in order to be ready to deal with cases coming up for hearing the next day.... Every judge spends an equal amount of time reading case files scheduled for the next day. Judgments are reserved on working days. On Saturdays, every judge sits down and dictates judgments. On Sundays, all of us read the cases listed for Monday. So, without exception, every Supreme Court judge works seven days a week.


Old Building, New Vision— Making the Supreme Court infrastructurally accessible


The Supreme Court of India, the apex judicial body in the country, is undergoing extensive infrastructural enhancements and renovations to improve its functionality, aesthetics, and accessibility. These ongoing works reflect the institution's commitment to providing a modern, efficient, and welcoming environment for judges, lawyers, litigants, and visitors.

One of the prominent projects involves the development of futuristic courtrooms (Nos 6-9), designed to integrate modern amenities, enhancing the judicial process's efficiency and experience. The courtrooms have been equipped

with state-of-the-art facilities, including advanced audio-visual systems, digital display boards, and improved seating arrangements for advocates and litigants. These changes are aimed at creating a more conducive environment for the dispensation of justice. Similarly, special repairs to the iconic central dome above Court No 1 are crucial to preserving the architectural heritage while ensuring structural integrity. Additionally, special provisions have been made for differently-abled individuals, ensuring that the Court is inclusive and accessible to all sections of society.

Infrastructure work is undertaken by the Court and Building Branch of the Supreme Court. Being the Apex institution of the country, the Supreme Court remains one of the busiest institutions year-round, with a mere 50-day vacation period providing the only window for substantial and heavy infrastructural undertakings, highlights Mr Patankar. Under the aegis of the Chief Justice of India, the Court has initiated repairs and upgrades to both the old and additional buildings to address previously cramped spaces. In the month

of June, 21 projects have been successfully completed and the remaining projects are likely to be completed before the court reconvenes on 8 July 2024, says Mr Patankar. During the vacation, the Chief Justice of India, along with the Secretary-General, Registrar Administration General, and other registry officials, conducted inspections of the ongoing work to ensure timely completion of these critical infrastructure projects.

In response to requests from the Supreme Court Bar Association (SCBA) and other stakeholders, the Supreme Court has addressed the need for larger spaces. The existing small room allocated to the SCBA has been expanded by merging two adjacent rooms creating a single, spacious area. Similarly, the Registrar Courts No 1 and 2 have also been merged to create a more accessible

area. These extensive projects, which typically require several months to complete, have been completed in record time during the Court's vacation period. The Court ensured that the upgrades were carried out without causing any disruption to the vacation bench or other stakeholders accessing the premises during this period.

Recruitment of new Law Clerk-cum-Research Associates

The process for selecting Law Clerk-cum-Research Associates, which began with a written exam on 10 March 2024, and was followed by interviews conducted in June, has now been successfully completed. This exam conducted under the aegis of the Committee for Law Clerk-cum-Research Associates comprising of Justice B V Nagarathna, Justice P S Narasimha, and Justice K V Viswanathan is designed to assess the

applicants' knowledge of legal principles, their analytical skills, and their ability to articulate complex legal concepts in a clear and concise manner.

The process was overseen by Mr Pradip Yeshwantrao Ladekar, Registrar (Human Resource). Speaking to the Chronicle team, Mr Ladekar mentions that "This year the exam was

conducted in a timely manner as per the model timeline given in the scheme of Engaging Law Clerk-cum-Research Associates available in the public domain. The posts were announced in January 2024, after which the exam was conducted in March 2024. The prestigious Clerkship examination which earlier used to be conducted in Delhi Centre only is now being conducted in Centres all over India via computer based test. This important step has increased the scope of opportunities to all deserving candidates from each corner of the country."

The newly appointed Law Clerk-cum-research associates are set to begin the assigned duties shortly. Starting in July, they will be posted with various Judges and within the registry. The orientation of the Law Clerks has been undertaken by the Centre for Research and Planning.



Staff Corner

For over thirty years, Ms Anju Arora has worked with many judges of this Court and all of her experiences have been rewarding in their own way. Six of them—Justice D P Wadhwa, Justice M Srinivasan, Justice B P Singh, Justice Aftab Alam, and Justice Vikramajit Sen—have served as Judges of the Supreme Court. Currently, she works with the Chief Justice of India, Dr D Y Chandrachud.

Born and raised in Delhi, Ms Anju grew up in a humble household alongside her five siblings. She credits her elder sister, who retired as a Registrar from the Supreme Court and was the first person in her family to earn a master's degree, as her source of inspiration. Following in her sister's footsteps, Ms Arora obtained a Master's degree in Hindi from Delhi University (DU), pursued a Bachelor of General Law (BGL), and qualified the clerical exam as a Junior Court Assistant. She later passed the stenographer exam and became Senior Personal Assistant. Ms Arora initially worked in the PIL Section before being transferred to the Court Masters wing and was later assigned to the Judges' residence.

Talking from her experience, Ms Arora mentions that one thing that she has unfailingly observed among all Supreme Court judges is the unmatched dedication to their work. Speaking about her current work at the Chief Justice's residence, she states, "This time in my career is the most inspiring and fulfilling for me in many ways." She particularly feels inspired by Ms Kalpana Das, wife of Chief Justice Dr D Y Chandrachud.

"I have learned and still learn a lot from Kalpana ma'am and the Chief Justice of India himself. In fact, I have never come across such people before. I have worked with many judges and each of my experiences have enriched me differently. But this is an extraordinary family to say the least, especially ma'am herself. She is an extremely generous lady. She is humble, down-to-earth, and very caring. I have seen how magnificently she looks after her two daughters who need constant care and special attention. In fact, she even goes the extra mile for the children of her staff. I have witnessed her personally giving time to each child who lives in

the staff quarters of the residence, listening problems. their taking interest in their educational endeavours. and providing every kind of support including financial. with no hesitation whatsoever."

Ms Arora feels that one should never

compromise on the education of children, especially in the case of female children. She believes that charity, though a personal affair, should be directed towards the education of less fortunate children. "Education gives you wings that are invaluable. You cannot obtain its benefits through anything but your own application. In fact, an educated mother is able to support her children's learning, even without financial means."

Ms Arora emphasises the importance of hard work: "Nothing can compensate for hard work," she says, and this has been her mantra throughout her personal and professional journey. When asked about her support system, given the demanding nature of her work, she says, brighteyed, "I owe my success to my husband. He has been a constant support and always had faith in me. Balancing a full-time career and parenthood can be challenging, but having the right support from your family or partner makes it easier."

She further gives credit to the safe working environment of the Supreme Court which has helped her in maintaining the balance. She believes that the Supreme Court provides a nurturing and safe environment for women who want to follow their dreams, and encourages more women to join this Apex institution, noting that it has done a lot to create an accessible and cooperative workplace for all genders. Thanking her colleagues Ms Arora shares that she has been fortunate to have a cooperative and trustworthy staff at all the residential offices which made my journey so far both encouraging and cordial.
