Terms and Conditions

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Candidates already serving in Govt. Department should submit their application through proper channel.

3. Preference will be given to those candidates who are working in Judicial Court.
4. Preference will also be given to those candidates who are having professional skills.
5. **Candidates must have passed Class VIII but Candidates who have passed H.S. or above shall be ineligible to apply for the aforesaid post.**
6. If any candidate is found to have suppressed his/her educational qualifications or given wrong information at the time of applying for job or later on, his/her candidature shall stand rejected without any information to him/her with immediate effect and shall also be liable to Criminal Prosecution as per law.
7. Candidates must not be less than 18 years of age or more than 40 years of age as on 01/01/2025. The upper age is relaxable as per Govt. norms.
8. The application with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste along with 03 (three) copies of recent passport size photographs duly signed by the candidate on the reverse side should reach the office of the undersigned.
9. **The applicant should mention their mobile number in the application without fail.**
10. **The last date of receipt of application form is 20/02/2025 up to 5:00 P.M.** No application will be accepted after the last date of submission. The office of the undersigned shall not be responsible under any circumstances for any postal delay.
11. Envelope containing application should indicate the name of the post and category to which they applied for on the top in the Block letters as **"APPLICATION FOR THE POST OF PEON"**. Those who failed to do so, their application shall not be considered under the said category.

12. The Selection Board has decided to hold Interview (*Viva-Voce*) for the aforesaid post. The eligible candidates applying for the post shall have to appear Interview (*Viva-Voce*) as and when called for.
13. The list of eligible candidates along with specific date of Interview (*Viva-Voce*) shall be uploaded in the official website of Chirang District Judiciary (<https://chirang.dcourts.gov.in/>) in due course. No separate call letters will be issued. Applicants are advised to go through the official website regularly.
14. The applicants shall submit their application in a drop box made available for the same in front of the office of the Chief Judicial Magistrate, Chirang, Kajalgaon or they may submit through ordinary postal service or speed post. Application sent through registered post or private courier service will not be entertained.
15. No TA/DA will be admissible to the candidates for appearing in the interview (*Viva-Voce*).
16. Application received late or without proper supporting documents or unsigned or without photographs or incomplete Application Form will be summarily rejected.
17. Canvassing directly or indirectly shall disqualify a candidate.
