1. Candidate must be an Indian Citizen as per the Constitution of India.
2. Candidate should not be less than 18 years and not more than 40 years as on 01- 01-2025. Relaxation 5 years for SC/ST (P)/ ST (H) and 3 years for OBC/MOBC as per Govt. Notification No.ABP.6/2016/51, Dated 02.09.2020.
3. Candidates must have registered their names in the Employment Exchange.
4. Candidates who are already in Govt. Service will have to apply through proper channel.
5. The applicant need to submit online application form and must have uploaded self-attested photocopies of all relevant testimonials regarding educational qualification, Experience certificate (wherever applicable), Caste, Age proof, Employment Exchange Registration Card, NOC from employer (wherever applicable) along with passport size photograph duly signed by the candidate on the reverse side.






