1. Candidate must be an Indian Citizen as per the Constitution of India.
2. Candidate should not be less than 18 years and not more than 40 years as on 01- 01-2026. Relaxation 5 years for SC/ST (P)/ ST (H) and 3 years for OBC/MOBC as per Govt. Notification No.ABP.6/2016/51, Dated 02.09.2020.
3. Candidates must have registered their names in the Employment Exchange.
4. Candidates who are already in Govt. Service will have to apply through proper channel.
5. The applicant have to submit standard form along with self-attested photocopies of all relevant testimonials regarding educational qualification, Experience certificate (wherever applicable), Caste, Age proof, Employment Exchange Registration Card, NOC from employer (wherever applicable) along with 02 (two) passport size photograph duly signed by the candidate on the reverse side.
6. Candidates must submit a Self-Declaration Certificate stating that he/she has not passed HSSLC or equivalent examination or above.
7. If any candidate is found to have suppressed his educational qualifications or to have given wrong information, at the time of applying for job or later on, his/her candidature shall stand rejected without any information to him with immediate effect and shall also be liable to Criminal Prosecution as per law.
8. Eligible candidates shall have to appear in the Written Test of 50 marks, comprising of following subjects English, General Awareness, Mathematical Ability, Aptitude and Assamese, followed by viva-voce for 20 marks
