



ADVERTISEMENT FOR RECRUITMENT OF PARA LEGAL VOLUNTEERS (PLVs)

It is for general information that District Legal Services Authority, Chirang intends to induct Para legal Volunteers (PLVs) for Chirang district. As such, applications from intending candidates from Chirang district are invited of the following groups of people.

Teachers (including retired teachers), Retired Govt. Servants and Senior Citizens, M.S.W. Students and teachers, Anganwadi Workers, Doctors/Physicians, Students & Law Students (till they enroll as lawyers), members of non-political, service oriented NGOs and Clubs, members of Women Neighbourhood Groups, Maithri Sanghams, Mahila Mitras and other Self Help Groups.

The candidates should have **minimum qualification of matriculation** with a capacity for overall comprehension who do not look up to the income they derive from their services as PLVs and who have a mind-set to assist the needy in society coupled with the compassion, empathy and concern for the upliftment of the marginalized and weaker sections of the society.

It is to be mentioned that the work of PLVs does not carry any salary, remuneration or wages except honorarium fixed by the Assam State Legal Services Authority from time to time (at present Rs. 750/- per day).

The Para Legal Volunteers are expected to act as intermediaries bridging the gap between the common people and the DLSA to remove impediments in access to justice. The works of PLVs among many others include to assist in organizing Legal Awareness Programmes, Legal Services Camp, Home visit to victims, Under Trial Prisoners, works related to implementation of various NALSA Schemes etc. The duties, function and remuneration of PLVs shall be governed by NALSA Scheme for Para Legal Volunteers and regulations in this regard from time to time.

The candidates shall have to mention in their applications about their willingness or place of preference to work at either district-level or village-level.

The duly filled up application in Standard Form with 02 (two) passport size photographs, original and self-attested photocopies of all educational testimonials and other relevant documents shall be received physically or through post at office of DLSA till **27-02-2026 at 5.00 PM**.
