1. Candidate must be an Indian Citizen as per the Constitution of India.
2. The application shall be addressed to "**the Secretary, District legal Services Authority, Chirang, Kajalgaon**" indicating the post applied for on the top of the envelop to the office of the Secretary, District Legal Services Authority, Chirang, Kajalgaon Pin: 783386 on or before **08/04/2026 by 05.00 PM.**
3. **Contact Numbers and e-mail ID (if any) of the applicants should be provided in the application.**
4. Candidates must have registered their names in the **Employment Exchange, Assam** and the Registration is to be valid on date of submission of applications.
5. Candidates must have passed Class VIII or equivalent from a Govt. recognized Board/Council. **The applicant must have a valid Light Motor Vehicle (LMV) Driving License issued by Competent Authority.**
6. The candidates must not be less than 18 years and not more than 40 years of age as on last date of receipt of applications. The upper Age limit is relaxable as per Govt. Rule.

7. The applicant need to submit **offline application in Standard form as published in Part-IX of the Assam Gazette** and must have enclosed self-attested photocopies of all relevant testimonials regarding educational qualification, Driving License, Experience certificate (wherever applicable), Caste Certificate, Age proof, Employment Exchange Registration Card, NOC from employer (wherever applicable) along with 02 (two) copies of recent passport size photographs duly signed by the candidate on the reverse side.
8. The filled application form must be super scribed "**Application for the Post of Driver**" on the envelope, along with Name, Address, Mobile/WhatsApp number and email ID (if available). The application must be submitted in the **Drop Box** at the office of the undersigned. Applications sent by registered Post/Speed post will be considered only if received in the Drop Box before the due date. Delay or non-delivery will be the candidate's responsibility, and late applications will be rejected.
9. If any candidate is found to have suppressed his educational qualifications or to have given wrong information, at the time of applying for the job or later on, his/her candidature shall stand rejected without any information to him with immediate effect and shall also be liable to Criminal Prosecution as per law.
10. Application submitted without proper supporting documents or incomplete application will be summarily rejected.
11. The eligible candidates shall be required to appear for Skill test, followed by Viva-voce.
