As approved by Hon'ble Executive Chairman, National Legal Services Authority, **2nd National Lok-Adalat** is scheduled to be held on **11th of May , 2024** during the Year, 2024. Therefore District Legal Services Authority, Budgam is scheduled to hold **2nd National Lok-Adalat**, on **11th of May, 2024** in District Court complex Budgam as well as Taluka Courts of District Budgam, for expected amicable settlement of all matters pending in the courts at various levels.

In this context, it is requested to all Learned Judicial officers of District Budgam to initiate the process by identifying maximum number of cases of different natures for subsequent settlement in the said National Lok-Adalat scheduled to be held on **11th of May 2024**. The list of identified cases shall reach this authority by or before **01-05-2024**, for onwards submission to J&K Legal Services Authority.

The following types of Cases may be taken up for Settlement in the afore said National Lok Adalat.

Pre-Litigation

- NI Act cases under section 138.
- Commercial/Money Recovery cases.
- Labour and Employment disputes cases.
- Electricity and water bills and other bill payment cases(excluding non-compoundable)
- Maintenance Cases.
- Others (Criminal Compoundable and other civil Disputes

- I. Criminal Compoundable Offences.
- II. NI Act case under section 138.
- III. Commercial/Money Recovery cases;

- VI. Disputes related to Public Utility services such as Electricity & Water Bills cases etc. (excluding non-compoundable);
- VII. Matrimonial disputes (except divorce)
- VIII. Land Acquisition cases;
- IX. Services matters including pension cases
- X. Revenue cases ,pending before district courts;
Other civil cases (rent, easmentary rights, injunction suits, specific performance suits etc.)

Besides Parties whose cases are not pending (Pre-litigation matters) in any court but desires to settle amicable their disputes can also approach District Legal Services Authority Budgam by or before 1st May 2024, so that their cases, claims/matters can settled amicable through the Lok Adalat
