Let the Appointment letters be issued to the selected candidates (except waiting list candidates) with the direction to join their post on or before 6<sup>th</sup> April 2024 and candidates shall produce all the original documents for verification such as educational certificates including matriculation in proof of their age, Medical fitness certificate issued by the Civil Surgeon and Caste certificate, Domicile Residential certificate (in case of reserved categories) issued by the competent authority of State of Jharkhand. Selected Candidates can also obtain their Appointment Letter in person from the office of Registrar, Civil Court, Latehar in case they do not receive appointment letter within time. Candidates are also directed to file an affidavit that he/she was not convicted earlier in any criminal case. Apart from that, selected candidates are directed to file an affidavit at the time of their joining with a declaration in a prescribed format for non-acceptance of dowry. The photograph, signature and handwriting of the selected candidates must be verified at the time of joining from the application form submitted by him/her earlier.

The validity of the waiting list shall as per rule and the vacancy created by the non-joining of any selected candidate shall be filled up from the list of waiting candidates.

No T.A. and D.A. shall be admissible to the newly appointed candidates for joining their post. Their service shall be on probation for a total period of two years within a continuous period of three years.

Registrar, Civil Court, Latehar is directed to publish the list of selected candidates as well as the waiting list of candidates on the notice board and the website of Civil Courts, Latehar.


