

NOTICE

All the concerned are hereby notified that the option for online payment of Court Fees has been initiated through <https://pay.ecourts.gov.in> for the District Court, Jhargram. E-payment of Court Fees is available on the above portal anytime and from anywhere. The Payment is collected by WBIFMS-GRIPS (Portal of Finance Department, Government of West Bengal) and the same can be made through Net-banking, Debit Cards, Credit cards and UPI mode.

It emphasized the importance of obtaining an acknowledgement slip containing the GRN Number, which must be presented with the cases to be filed physically as evidence of payment of Court Fees. The notice stressed that the exact amount of court fees should be deposited during e-payment, as partial usage of court fees and partial validation will not be allowed.

Furthermore, it highlights the necessity of selecting a specific establishment at the time of e-payment (e.g., District and Sessions Judge, Jhargram, Chief Judicial Magistrate, Jhargram, Civil Judge Sr. Divn, Jhargram, or Civil Judge Jr. Divn, Jhargram) and be noted that Court Fees purchased for one establishment cannot be used for cases pertaining to another establishment.

Alert: Users are requested to make payment only through the above portal and no other unauthorized portal. Users would be solely responsible for making payment in any other portal other than the above-mentioned portal. Additionally, it is clarified that the District Court at Jhargram will not be responsible for any failure of payment or other payment issues, since the same is collected by the WBIFMS-GRIPS.

Users are also requested not to share the OTP and other details, necessary to make an e-payment. They should avoid taking fishing calls or any call from anyone seeking banking user id/password details or OTP, Credit Card/Debit Card details.
