

With reference to the subject, as directed, I am to state that, the Registry has proposed to extend the facility of mandatory e-Filing of Second Appeal, Criminal Appeal, all Bail Applications and all Criminal MPs dealing with relaxation of condition, extension of time for furnishing sureties and modification of Bail Condition, etc., in the Madras High Court, Madurai Bench of Madras High Court and to the Bail Applications and its allied matters, Partition Suits, Mortgage Suits, Eviction Suits, Suits for Possession, Pre-emption Suits, Suits for Accounts, Suits for dissolution of partnership and Specific Performance Suits in the District Judiciary on and from 01.04.2024.

In this regard, the High Court, Madras has issued a Notification towards extending the facility of mandatory e-Filing of cases to the said case types from 01.04.2024 and the same has been hosted in the Official Website of Madras High Court.

Therefore, I am to request your goodselves to give necessary instructions to all concerned towards hosting of Notification in the District Court Website; sensitizing the Advocates towards e-filing facility through their respective Bar Association and not to insist the filing of physical copies.

I am further to request your goodselves to give necessary instructions to all Judicial Officers and the staff concerned for scrutinising the Bail Applications and its allied matters, Partition Suits, Mortgage Suits, Eviction Suits, Suits for Possession, Pre-emption Suits, Suits for Accounts, Suits for dissolution of partnership and Specific Performance Suits in the District Judiciary filed through e-filing without any delay.
