Applications are invited from the local residents of Kamrup Rural District belong to tea tribe community in standard form along with two nos. of passport size photographs for selection of 05 (five) nos. of Para Legal Volunteers (PLVs) in the establishment of District Legal Services Authority, Kamrup, Amingaon.

**DETAILS AND TERMS & CONDITIONS:**

- i. He/ She must be a citizen of India and a local resident of Kamrup Rural District.
- ii. He/ She must be from tea tribe community
- iii. The applicant should have minimum qualification of matriculation with a capacity for overall comprehension and should have mindset to assist the needy in society coupled with compassion, empathy and concern for the upliftment of marginalized and weaker sections of the society.
- iv. The minimum age for selection of Para Legal Volunteers should not be less than 18 years as on 01.01.2025.
- v. The application should be addressed to the Chairman, District Legal Services Authority, Kamrup, Amingaon. Incomplete applications will be rejected without assigning any reason.
- vi. Filled up application in proper order should reach the given address on or before **15.09.2025**. The applicant should submit their mobile/ contact number, email id for further communication, if any.
- vii. No applications will be entertained after the last date fixed and this Authority is not responsible for any postal delay.
- viii. **The work of PLVs doesn't carry any salary, remuneration or wage except honorarium fixed by the District Legal Services Authority, Kamrup, Amingaon from time to time, as per rules.**
- ix. The decisions of the Selection Committee in short listing the number of candidates for interview and selection of PLV shall be final. The eligible candidates shall have to appear for Interview before Selection Committee, the date of which will be notified in the official website.
- x. Selected PLVs shall be required to undergo training programme as per decision of the District Legal Services Authority, Kamrup, Amingaon.


- xi. List of shortlisted candidates for interview will be notified in the office notice board and will also be published in the official website of District Judiciary i.e. [https:// kamrup.dcourts.gov.in/](https://kamrup.dcourts.gov.in/).
- xii. Canvassing directly or indirectly shall disqualify the candidates.
- xiii. No TA/DA will be provided for appearing in the interview.
