Applications are invited in Standard form as published in Assam Gazette in Part IX from the eligible candidates who are citizen of India as defined in Articles 5 and 6 of the Constitution of India for engagement of **01 (one) Driver (Contractual)** in the office of the District Legal Services Authority, Kamrup, Amingaon at a monthly remuneration of Rs. 15,000/ (Rupees Fifteen Thousand) only.

The engagement shall be purely Contractual. The Contract period may be extended depending upon requirement and performance which shall be subject to the approval of the Assam State Legal Services Authority, Guwahati.

How to apply: Candidates are required to submit their applications directly to the office of the District Legal Services Authority, Kamrup, Amingaon.

Other Terms and Conditions:

- Candidates must submit self-signed copies of relevant testimonials/certificate regarding educational qualification, age, caste, employment exchange registration card, experience certificate (if any), valid professional driving license and two recent passport sized photographs along with the application.
- Candidates are required to provide their phone number (preferably WhatsApp No.) and E-mail ID in the application form without fail.
- Candidate must be an Indian Citizen as defined in articles 5 to 8 of the Constitution of India: ordinary resident of Assam.

4. A candidate must not be less than 18 years and not more than 40 years of age as on 31/03/2026. In appropriate cases, relaxation of age will be admissible as per the existing rules of Government of Assam.

Eligible Candidates for skill test/signage and interview have to produce **Original** testimonials regarding educational qualifications, date of birth, caste, employment exchange registration card, valid professional driving license, working experience (if any) at the time of skill test/signage and Interview for the purpose of verification and scrutinization.

9. No TA/DA shall be admissible to the candidates for appearing in the skill test/signage and interview.
10. Candidates who are already in Government Service (Central/State Or PSU) may apply through proper channel. They shall have to produce "No Objection Certificate" from the present employer at the time of document verification and they will have to submit release order at the time of joining.
11. Candidates must mention prominently the name of post applied for on the right-hand corner of the envelope containing the application.
