Consequent upon the retirement of the following incumbents, Four (04) posts in the cadre of Senior Sheristadar in the scale of pay of Rs-9000/- to 40500/- with Grade Pay of Rs-4700/- (P.B-4), corresponding to scale of pay of Rs-39900/- to 102800/- (Level-14) as per ROPA'2019 are lying vacant.

In compliance of the recommendation of the Shetty commission for upgradation/ promotion of the post of Sheristadar, Civil Judge (Senior Division) Court or the posts in its equivalent, Government of West Bengal Judicial Department has issued memorandum being No. 204 JD/L/2S-23/04 (Pt-IV) dated-08.05.2015 read with 99-JD/L/2S-23/04 (Pt-VI): dated-31.05.2018 with concurrence of the Finance Department Group-PI G.O vide their U.O. No. Group-PI/2018-2019/0059 dated-24.05.2018 and this office issued Establishment Order being no. 21: dated-02.03.2021 for implementation of the recommendation regarding upgradation/promotion of the post of Sheristadar, Civil Judge (Senior Division) Court or its equivalent designated as Senior Sheristadar in the Sub-ordinate Courts in West Bengal in the pre-revised scale of pay of Rs-5500-11325 (ROPA'98) to P.B-04 of Rs-9000-40500/- with Grade pay of Rs-4700/- (as per ROPA 2009) w.e.f 01.04.2003, O.P.R, letter of Willingness and Service Book of the candidates who are under the zone of consideration for promotion as per seniority in the scale of pay of Rs-Rs-9000/- to 40500/- with Grade Pay of Rs-4400/- (P.B-4), corresponding to scale of pay of Rs-38500/- to 92100/- (Level-12) as per ROPA'2019) were called for and subsequently sent to the concerned committee for consideration for the matter of promotion in the four (04) vacant posts in the cadre of Senior Sheristadar in the scale of pay of Rs-9000/- to 40500/- with Grade Pay of Rs-4700/- (P.B-4), corresponding to scale of pay of Rs-39900/- to 102800/- (Level-14) as per ROPA'2019.

It is stated in the report submitted by the Chairman, Promotion Committee that the four (04) vacancies deserve to be fulfilled on the basis of seniority-cum-merit in conformity with 50 point roster as per schedule II of West Bengal Scheduled Caste and Scheduled Tribe (Reservation of vacancies in Services and Posts) Act, 1976 and according to Sheduled-II (section-5) of the Act, the first vacancy will be filled by Scheduled Caste candidate, second and third vacancies by Unreserved candidates and fourth vacancy will be filled by Scheduled Tribe candidate. The Committee recommended the names of the following staff for consideration for the promotion in the vacant posts in the cadre of Senior Sheristadar in the scale of pay of Rs 9000/- to 40500/- with Grade Pay of Rs-4700/- (P.B-4), corresponding to scale of pay of Rs-39900/- to 102800/- (Level-14) as per ROPA'2019

Perused the said report, it appears from the report that the above-mentioned incumbents have been recommended for promotion to the post of Senior Sheristadar (in the scale of pay of Rs-9000/- to 40500/- with Grade Pay of Rs-4700/- (P.B-4), corresponding to scale of pay of Rs-39,900/- to 1,02,800/- (Level-14) as per ROPA'2019) after observing all paraphernalia in the matter of promotion. Hence the report is considered and accepted and the following order is passed in the interest of public service.
