Consequent upon G.O. No. 5142-J and 5143-J both dated 20.09.2009 in compliance with the order passed by the Hon'ble Supreme Court of India in I.A. No. 71 A, 135-136, 137-138 and 142 in W.P.(C) no. 1022 of 1989 and on strict compliance of the Finance Department's Memo No. 3840-F (P) dated 23.07.2014 subsequent Memo No. 4550-F (P) dated 11.06.2015, the 17 (Seventeen) vacancies in the post of Upper Division Clerk in the scale of Pay Rs-7,100/- to 37,600/- with Grade pay Rs-3600/- corresponding to scale of pay of Rs-28,900/- to 74,500/- (Level-09) as per ROPA'2019 arising out of promotion and retirement of some staff should be filled up from the senior most eligible Lower Division Clerks as per Gradation List and in consultation with 50 point roster of reservation.

O.P.R and Willingness have been called for from the next senior most employees as per Gradation List holding the post of Lower Division Clerk in the ratio of 1:5 for consideration for promotion to the post of Upper Division Clerk in the scale of Pay Rs-7,100/- to 37,600/- with Grade pay Rs-3600/- corresponding to scale of pay of Rs-28,900/- to 74,500/- (Level-09) as per ROPA'2019 and the same has been sent to the Promotion Committee, District Judge's Court, Paschim Medinipur.

Report was called for from the Promotion Committee, District Judge's Court, Paschim Medinipur.

It is stated in the report submitted by the Chairman, Promotion Committee that the Seventeen (17) vacancies deserve to be fulfilled on the basis of seniority-cum-merit in conformity with 50 point roster as per schedule-II of West Bengal Scheduled Caste and Scheduled Tribe (Reservation of vacancies in Services and Posts) Act, 1976. The Committee recommended the names of the following staff for consideration for the promotion in the vacant posts in the cadre of Upper Division Clerk in the scale of Pay Rs-7,100/- to 37,600/- with Grade pay Rs-3600/- corresponding to scale of pay of Rs-28,900/- to 74,500/- (Level-09) as per ROPA'2019
