## **Terms and Conditions:**

- 1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
- 2. Candidates must have registered their names in the Employment Exchange and the Registration is to be valid as on date of submission of applications.
- 3. Candidates serving in Govt. Department should submit their application through proper channel.
- Candidates must have passed Class VIII or read up to Class XII. Candidates who
  possess a Graduate Degree or above shall be ineligible to apply for the said
  post.
- 5. If any candidate is found to have suppressed his/her educational qualifications or given wrong information, at the time of applying for job or later on his/her candidature shall stand rejected without any information to him/her with immediate effect and shall also be liable to Criminal Prosecution as per Law.

7. The application in Standard Form (published in the Gazette Part IX of Govt. of Assam) with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste, Valid Employment Exchange Registration Card, Valid Driving License, Experience

Certificate (wherever applicable) along with 3 (three) copies of recent passport size photographs duly signed by the candidate on the reverse side should reach the Office of the District and Sessions Judge, Jorhat.

8. The applicant must have a valid Driving License (LMV) issued by competent Authority.

- The applicants shall mention their Mobile Numbers in the application form without fail.
- 10. The **last date** of receipt of application is **23.11.2023**. No application will be entertained after the last date. The appointing authority shall not be responsible under any circumstances for any postal delay.

11. The eligible candidates shall be required to appear for screening written test, followed by driving test and viva-voce.

- 12. The candidates shall be required to appear in the screening written test (Objective Type) for 50 marks of 1 hour (60 minutes) duration. The syllabus for the screening written test will be General Knowledge (20 marks), Road Sign Recognition (20 marks) and Assamese language (10 marks). The Screening Test will be of qualifying nature and marks obtained therein will not be considered while preparing the final select list. The shortlisted candidates will be required to appear for driving test and viva-voce.
- 13. The candidates who qualify the screening written test will be called for driving test. The driving test will be on the segments namely, Starting, Driving, Parking and After Driving (10 marks for each segment, total 40 marks).
- 14. The driving test shall be followed by interview/viva-voce for 10 marks. The final select list will be prepared on the basis of the sum total of marks obtained in driving test and viva-voce.
- 15. No individual call letters will be sent to the eligible candidates. However, list of candidates to be called for screening written test as well as for driving test and viva voce will be uploaded in the official website of Jorhat District Judiciary (<a href="http://jorhatjudiciary.gov.in">http://jorhatjudiciary.gov.in</a>) and candidates will download the same from the official website. The list of rejected candidates will also be uploaded in the official website.

- 17. No T.A./D.A. will be admissible to the candidates for attending the interview process.
