

Regarding appointment of additional Notary Public for Jorhat District Head Quarter and Titabor Sub-Division in the ratio of 1:3, as per letter no. Ecf No. 237728/2022/13, Dated: 17/04/2023 of the Secretary to Govt. of Assam, Judicial Department.

Resolution:

A meeting was held today i.e., on 16/08/2023, in the chamber of the District & Sessions Judge, Jorhat at 6:00 PM to finalize 6 (six) names of learned Advocates to be sent to the Judicial Department, Govt. of Assam for 2

THICT JORHAT

(two) more vacant posts of Notary available at Jorhat. Further, 3 (three) names of learned Advocates from Titabor Sub-Division are to be finalized for 1 (one) post of Notary in the said Sub-Division.

For the said exercise, the applications received were perused for Jorhat, 42 No. of applications were received from interested learned Advocates and for Titabor Sub-Division, 12 No. of applications were received from the learned Advocates of Titabor Sub-Division, which were forwarded to this establishment by the Office of the learned S.D.J.M. (M), Titabor.

After threadbare discussion, it was decided that names should be recommended in **3 (three) bands** – (i) **Senior Band**, comprising of learned advocates having experience of 15 years and above; (ii) **An Intermediate Band** – comprising of learned advocates having experience of 12 to 15 years & (iii) **A relatively Junior Band** – comprising of learned advocates having experience up to 12 years.

Further, considering the number of applications received for Titabor Sub-Division the bands have been categorized as follows — (i) Senior Band, comprising of learned advocates having experience of 12 years and above; (ii) An Intermediate Band — comprising of learned advocates having experience of 10 to 12 years & (iii) A relatively Junior Band — comprising of learned advocates having experience up to 10 years.

2 (two) nos. of candidates have been selected from each band from Jorhat and for Titabor Sub-Division. 1(one) no. of candidate from each band.

Further, efforts have been made to maintain an equitable gender balance in each band. The names have been recommended in the ratio of 1:3 as directed by the letter dated 17/04/2023.

Keeping this broad criteria in mind, the applications were perused and the following 3 (three) learned Advocates are hereby recommended for 1 (one) post of Notary for the Titabor Sub-Division –
