The quotations shall be submitted to this office **on or before 29/01/2025** as per specification enclosed with this notice.

1. The sealed envelope duly marked as "Tender for Refilling of Fire Extinguishers" and the following documents must be annexed with the quotation.
  - a) Copy of PAN Card.
  - b) Up to date copy of G.S.T Registration certificate.
2. Each page of the documents should be signed by the bidder with seal to establish the Bidder's eligibility and its qualification to perform the work if its bid is accepted. In the absence of any of the above documents / information, the offer may be summarily rejected without making any further reference in this regard.
3. The sealed quotation should be submitted to the office of the District & Sessions Judge, Jorhat, during office hours on working days.
4. The Parties also have to submit firm's Bank account number.
5. The quotation will be opened **on 30/01/2025** in the office chamber of the undersigned. (if any changes on the date of opening the sealed quotations occur owing to any unavoidable circumstances, it would be intimated in the **official website only**)
6. Rate quoted for the items will be final and no further hike in price of the items will be entertained.
7. The rates approved, shall be valid for a period of one year from the date of issue of Notice by this establishment. Increase and decrease of Prices, Taxes and other statutory duties will not affect the price during this period. The supplier will be responsible for any increase in Prices, Taxes and Duties. Any increase in taxes and other statutory duties/levies after the approval of rates shall be to the supplier's account.
8. Payments shall be made after satisfactory execution of the order in satisfactory condition on bill basis. The decision of the District and Sessions Judge, Jorhat, towards satisfactory performance of work shall be final.
