- II. Tenderer should provide Income Tax Return for the last three financial years along with copy of Pan Card, GSTIN, any document for address proof, Registration No. & date, and Account Details such as Account Type, Account Holder Name, A/c No., Bank IFSC Code.
- III. The Tenderer may provide the details of any previous printing & supply (along with quantity and value of contract) made to any Government Organizations in the last 3 financial years.
- IV. Sample of Forms may be perused in the office.
- V. The Tenderer shall quote the rate inclusive all taxes. The rate should be written both in numbers as well as in words.
- VI. No extra charges (including freight) will be acceptable.
- VII. The period for completion of work will be 15 days from placing of work order.
- VIII. Payment will be made after the satisfactory completion of the work and no advance payment shall be made in any condition.
