In view of order dated 18.01.2024 of the Hon'ble Patna High Court passed in L.P.A. No. 727/2023 in C.W.J.C. no. 1414 of 2019 as well as resolution of the 'Centralized Selection & Appointment Committee' dated 04.03.2024, the list of ten (10) petitioners candidates of C.W.J.C. nos. 1414/2019, who finds place in the merit list prepared against the vacancy arise due to non-joining of the selected candidates & accrued vacancies up-till 26.09.2020, and accordingly, selected for appointment to the post of Clerk in the Civil Courts of Bihar pursuant to Employment Notice No. 01/2016; is being published below with their place of posting.

In view of Hon'ble Court letter no. 23723/File No. IV-57-2023/A.D. (Misc.) Section dated 22.03.2024, the list has already been approved by the Hon'ble Court.
