- II. Tenderer should provide Income Tax Return for the last three financial years along with copy of Pan Card, GSTIN, any document for address proof and Account Details such as Account Type, Account Holder Name, Bank A/c No. with IFSC Code.
- III. Tenderer should also file the details regarding the experience of providing services in the field for the last three years.
- IV. The Tenderer shall quote the rate inclusive all taxes. The amount should be written both in numbers as well as in words.
- V. No extra charges will be acceptable.
- VI. Payment will be made on successfully Completion of work subject to availability of fund and no advance payment shall be made in any condition.
- VII. The work is to be completed within 20 days from work order.
