- I The Quotations should be accompanied by Earnest Money Deposit (EMD) of Rs.10,000/- (Ten Thousand) only in the form of Demand Draft/ Fixed Deposit Receipt/ Bankers cheque or unconditional Bank Guarantee from any of the Commercial/ nationalized/ scheduled banks in an acceptable form drawn in favour of the Registrar, Civil Courts, Patna, without which the quotations will not be considered. The earnest money will be returned to all the unsuccessful Tenderer after finalization of the Contract without interest.
- II Tenderer should provide Income Tax Return for the last three financial years along with copy of Pan Card, GSTIN, any document for address proof, Registration No. & date, and Account Details such as Account Type, Account Holder Name, A/c No., Bank IFSC Code.
- III The Tenderer may provide the details of any previous work in any Government Organizations in the last 3 financial years.
- IV The contract will be initially for a period of **one year** which may be extended for another year.
- V The place of performance will be Patna Districts Courts and its Sub-Divisional Courts.
- VI They should attend all the complaints, irrespective of its nature without fail within the shortest possible time and in no case the down time shall exceed 1 day.
- VII The Tenderer shall quote the rate showing all taxes for **Service Charges and price list of Consumable items for single (per Gen. set) Generator set.**
- VIII No extra charges will be acceptable.
- IX There is no obligation on the part of the District Court, Patna to inform the unsuccessful Tenderer of the outcome of the tender process and reasons for rejection of Tender.
